MINUTES

The Marshall County Board of Supervisors met in regular session according to the posted notices in the 3rd floor conference room, Sheriff's Complex, 2369 Jessup Avenue, Marshalltown, Iowa, and online via ZOOM. Chair Heil called the meeting to order on May 10th, 2023, at 9:00 a.m. Present: Chair Jarret Heil, Vice Chair Steve Salasek, Member Carol Hibbs. Salasek moved to approve the agenda, second by Carol Hibbs. Motion carried 3-0.



Motion by Carol Hibbs, second by Steve Salasek, to approve the monthly rates Marshall County Employee Health and Prescription Drug Benefit Plan and Marshall County Employee Dental Benefit Plan Vision Rates Discussion and action on setting the monthly rates for FY24 as set out below. Motion carried 3-0.

Health and Prescription Drug Benefit Plan:

Single - \$836.18
Employee plus one - \$1,344.56
Family - \$1,796.08

Dental Benefit Plan:

Single - \$41.06
Employee plus one - \$82.12
Family - \$93.64

Vision Benefit Plan:

Single - \$8.66
Employee plus one - \$15.16
Family - \$22.52

The board discussed the request by the Courts to increase public counter height to standing height, contract change order #112, \$56,437.50 plus delay, which could add 2-3 months to the project schedule. Building and Grounds Director Baedke explained the request, and after discussion, the board decided to take no action at this time, as this could be a future project after the Courts move in to the new space. Motion by Carol Hibbs second by Steve Salasek to approve the purchase of courtroom benches for 8 courtrooms in the Marshall County courthouse, in the amount of \$35,946.90, with a 12-14 lead from (New Holand Furniture, Pennsylvania and authorize Chair to sign, if necessary. Motion carried 3-0.

Public Forum: Auditor & Recorder Nan Benson provided move update on courthouse with state elevator inspection and IT Director Nehring provided update on computers delaying move. The courthouse move has been rescheduled to begin on Thursday May 18th – Monday May 22nd and be open to the public on Tuesday May 23rd. Harold Lanning presented a request for a speed trailer on Wallace Ave, Deputy Ben Veren offered to follow up Emergency Management Coordinator Kim Elder provided an update on the siren project RFP and will be requesting bids after approval from the state. A meeting will be set when approval is granted.

Adjournment. The next regular session is Wednesday, May 24, 2023, at 9:00 a.m. All business to be acted upon at that session should be submitted to the County Auditor and Recorder's Office or the Board of Supervisors' Office by Wednesday, May 17, 2023, at 12:00 p.m. There being no further business to come before the Board, the meeting is adjourned at 10:28 a.m.
